• Recommended Action Items:

FY21 Budget Highlights

- 1. FY21 budget projects an overall 1.3% increase in our operating expenses from FY20 budget
 - FY19: \$25,384,024
 - FY20: \$25,839,168
 - FY21: \$26,175,490
- 2. Staffing Changes

- FY19: 233.6 FTE
- FY20: 228.4 FTE
- FY21: 230.6 FTE
- 3. **2% COLA Increases** for Unit A (Professionals) and Unit B (Paraprofessionals) as well as non- collective bargaining staff.
- 4. Step Increases are projected to increase salaries in FY21 by \$155K.
- 5. Staff Lane Changes for FY21 added \$16.4K to the FY21 salaries budget.
- 6. Health insurance
 - We have 176 active employees enrolled in GIC. Using actual costs, we are projecting health insurance to increase 6% by incorporating higher FY21 GIC premiums (larger weight on Tufts plans) and slight increase in enrollments (for new hires).
 - 89 families plans
 - 87 individuals plans

7. Retiree Health Insurance: We are contributing towards the premiums for **36** retirees (including spouses) and reimbursing Burlington for **8** retirees who were grandfathered. These costs are included in our budget.

- FY18: 201,895 = \$178,857 + \$23,038 (8 Burlington retirees)
- **FY19:** \$230,902 = \$206,712 + \$24,190
- **FY20:** \$237,940 = \$209,540 + \$28,400
- **FY21**: \$239,870 = \$208,670 + \$31,200

8. Worker's Comp Insurance is projected to go down \$20K in FY21 as our most recent MOD rating was much improved (down to 1.08) and realize savings from switching carriers (to MEGA).

- **FY18:** \$196,496
- **FY19:** \$193,072
- **FY20:** \$182,439
- **FY21:** \$162,785

9. FY21 Facilities Rent contracts include the Central Office space (\$68K), the Woodland House (\$20K), and misc. space rental for our programs and events (\$25K).

10. Substitutes & Program Support remain a challenge as we continue to have elevated needs for quality substitutes and nurses on an ongoing basis.

- **Substitutes** line item has been increased \$36K
- Nursing and Misc. Services was increased by \$96K

11. External Transportation (Lexington, Arlington, Burlington, Belmont, Waltham, Watertown, Weston)

• Students transported to your in-district programs and out-of-district placements by vendors and coordinated by LABBB's Transportation Coordinator.

- FY21 we anticipate the External Transportation budget to stay relatively flat due to a contracted vendor increase of 1% offset by a modest decrease in ridership
 - **FY18:** \$6,565,013
 - **FY19:** \$6,724,192
 - **FY20:** \$6,905,738
 - **FY21:** \$6,906,303

12. Internal LABBB Transportation (Students enrolled in LABBB and transported to a LABBB program, on a LABBB leased vehicle, by a LABBB staff person)

- Total expense associated with Internal Transportation is projected to be **\$708K** in FY21
- Collaborative member assessment will be allocated using student ridership percentages as of November
 - **FY18:** \$312,000
 - **FY19:** \$278,139
 - **FY20:** \$318,000
 - **FY21:** \$306,475 (23 drivers at \$65/day)

13. FY21 Tuition Increase

- **2%** increase across all programs
- 296 students (based on 96% of 308 projected enrollments)
